Member’s guests benefit from 20% off the designated greens fee rate. GHIN Handicap system access. Dues are billed on the 1<sup>st</sup> of the month and are due by the 20<sup>th</sup> of the same month. First month’s membership is due upon application, plus 7% tax. Corporate memberships must provide corporate documents and dues must be paid by that company.

Members may request a medical leave for one month out of a year, with a doctor’s note. If approved, the monthly dues may be waived. If a cart owner, cart storage fees will still apply.
