

Congratulations

The 2024 Club Championship took place over consecutive weekends: March 9, 10, 16 & 17. The final matches in the Mens & Ladies Championship flights both went to sudden death and the Men's First Flight was decided on the final hole. Dahl Flynn and Jason Davis were all tied after 36 holes in the men's final match and Dahl won his fifth trophy on the 1st playoff hole. Julie Treadwell and Mary Dee Snow were both going for their 2nd Champion's trophy in the ladies final match. **Julie** won in 2022 and Mary Dee in 2018. They were tied after 18 holes and Julie won on the 1st playoff hole. In the Men's First Flight Boomer Pagley was 1 down to Jerry **Lindow** with two holes to play and finished with two pars for a 1-Up victory. In the Ladies Consolation Flight final match, five time Ladies Club Champion Nan Habjan prevailed over Lisa Branum.

The first of three playoff events was held at Cypress Run on March 21. Cypress Run won the club competition with a 271, with Ardea and Countryside tying for 2nd at 274, followed by **Clearwater** in 4th place with a 276 and finally Pasadena in 5th with a 280. So after one playoff event, the clubs and playoff point totals are: Cypress Run - 5, Ardea & Countryside - 3.5, Clearwater - 2 and Pasadena – 1. **Gregory McClimans** posted a 76 to place 4th in the Pro Competition.

Rules Quiz

Molly and Judy were playing a match and on the 4th hole Molly's drive was in the right rough, Judy was in the fairway. They both hit their 2nd shots. Upon arriving at the green, Molly reported that her ball may have moved slightly during her backswing, but she kept going with the swing. She wasn't sure if she had caused the ball to move, or even if it had moved. What is the ruling? Looking at Rule 9.1b, since it is not virtually certain that the ball moved or, if it did move, what caused the movement, there is no penalty. If Molly was sure that she had caused the ball to move, by continuing with the swing she would have been "playing a ball from the wrong place" in breach of Rule 9.1 and would incur loss of hole (or 2 stroke penalty in stroke play).
